BREWING INDUSTRY ANNOUNCES MERGER OF TRADE ASSOCIATIONS

Carlstadt— January 17th, 2024 — The two trade associations representing New Jersey's craft brewing

industry have joined forces through a merger to be finalized next week at an open-house meeting for all

breweries, brewpubs, and breweries-in-planning throughout New Jersey, to be held at Bolero Snort

Brewery.

For the last two years, both associations have been working together closely with common goals and

priorities. This lock-step approach set the framework for internal conversations about the logistics of the

eventual merger, while also carrying out the strategy developed for the passage of S4265, landmark

legislation to end 6 years of oppressive and damaging regulations surrounding tasting room operations

within New Jersey.

"We have always been a small industry and everyone maintains a lot of strong relationships with other

businesses in the state," said Scott Wells, Owner of Bolero Snort Brewery and Brewers Guild of New

Jersey board member, "Uniting into a single unified voice will make it easier to work with external

partners, including the state's legislature and regulatory bodies, and focus on the matters that impact the

entire industry the most."

Industrial impact

The impact of this newly reformed group will be realized immediately as the breweries navigate a new

world where the post-covid economic climate and shifting customer demands still loom large over the

industry as a whole despite the easing of some governmental red tape. The new group will take on these

new challenges to help New Jersey rise to the forefront of the industry at large - a level of prominence it

has long deserved with exceptional quality and countless awards to boast. While still one of the fastest

growing industries in the country, New Jersey remains well behind other states in beer produced,

breweries per capita, and economic impact.

"We're excited to move beyond the legislative agenda that had dominated the industry for a significant

time in recent years," Krystle Lockman, Owner of Axe & Arrow Brewing and New Jersey Brewers

Association board member. "Now we will shift towards fostering industrial excellence through

continued educational opportunities, sharing of best practices, relationship building, and a larger and

more diverse team."

For now, the combined association will operate as the Brewer's Guild of New Jersey. Scott Wells of Bolero Snort

Brewery and Michael Kane of Kane Brewing will remain on the Executive Board of Directors, and will be joined

by New Jersey Brewers Association board members, Krystle Lockman of Axe and Arrow Brewing and Denise

Ford Sawadogo of Montclair Brewery. Eric Orlando of The Zita Group, which was instrumental securing in the

passage of the new law, will remain on as the association's contract Government Affairs counsel. Alexis Degan,

who previously helmed The New Jersey Brewers Association has joined the team as the Executive Director.
